#### A.I. JURISTS ONLINE ADVANCE PRE-BAR (JOAP)

**EARLY-BIRD RATE:** ₱14,000 if paid on or before 15 November 2023. (Availing of the early-bird rate is a waiver of any other discount).

**REGULAR RATE:** ₱14,500 if paid on or after 16 November 2023.

**DISCOUNTED RATE:** ₱13,775. This is for:
